### **PRIVACY ACT 1993**

This information is being collected and will be held by New Zealand Thoroughbred Racing (NZTR) at 106-110 Jackson Street, Petone, Wellington. It is principally being collected for the purpose of processing the matters that are the subject of this form. You agree that the personal information supplied by you may be retained by NZTR and disclosed to, and retained by, third parties for the purpose of processing relevant forms, data matching, direct marketing and providing you with information on events, products and/or services.

NZTR will not use or disclose your personal information in any way, other than in accordance with this policy or with your prior consent. ### **CREDIT CHECKING**

All riders that are granted a Class A, B, D or E Rider's Licence for the first time by NZTR will automatically be granted a Class B Trackwork Rider's Miscellaneous Licence as a condition of that licence under rule 314(3).

#### **DECLARATION BY APPLICANT**

I do hereby declare that:

- 1. By signing and submitting this form to New Zealand Thoroughbred Racing Inc (NZTR) I have read the form and all of the information that I have provided to NZTR in this application form is true and correct in every particular.
- 2. I understand that NZTR will rely upon the information I have provided in this application form for the purpose of determining whether I am an appropriate person to receive a Class E rider's licence.
- 3. I understand that NZTR may take disciplinary action against me in the event that the information I have provided in this application form is false or misleading in any particular, and that disciplinary action may include revocation of any licence issued to me.
- 4. I acknowledge that the provision of any false, misleading or inaccurate information on this form may result in me being prosecuted under the NZTR Rules of Racing or otherwise. I confirm with the requirements listed therein and that I:
  - (a) have not in the previous 12 months received any money or valuable consideration for riding in a Race, other than a trophy given under the conditions of the Race;
  - (b) have attained the age of 15 years;
  - (c) am competent to ride in Races, trials (including jump-outs and tests for certification purposes) and trackwork; and
  - (d) am of good character.
- 5. I have obtained a copy and informed myself of the NZTR Rules of Racing and it is my obligation as a holder of a Class E rider's licence to update myself in relation to NZTR's policies and any rule changes and to abide by those policies and Rules of Racing.
- 6. In accordance with Rule 656 of the NZTR Rules of Racing, I consent to providing a sample of my blood, breath, urine, saliva or sweat (or more than one thereof), as and when required by a Stipendiary Steward or Investigator, for the purposes of drug and alcohol testing.
- 7. I am not currently subject to any disciplinary action initiated by any other Racing Authority in New Zealand or overseas and I will immediately inform NZTR should any other Racing Authority in New Zealand or overseas initiate disciplinary action against me.
- I understand that if I do not pay any amount owed to NZTR within the required time, NZTR may set-off this debt against any prizemoney due and owing to me through the TROSA system administered by NZTR.

# RULE OBLIGATIONS FOR A RIDER APPLICANT

## As an applicant for approval as a rider I am advised and understand as follows:

- 1. That I am aware the current New Zealand Rules of Racing are available for viewing on the NZTR website <a href="https://www.nzracing.co.nz">www.nzracing.co.nz</a> and I acknowledge and agree that this document is not a complete list of all of the obligations I have under the Rules of Racing as a rider.
- 2. That I am at all times deemed to have full knowledge of the New Zealand Rules of Racing. RULE 101 (3)
- 3. That the NZ racing season is from the 1 August to the 31July in the following year and that no later than the 1 July, I am required to apply to NZTR for renewal of the license/certificate on issue to me. **RULE 319**
- 4. That I am bound by the Rules and if I misconduct myself in any way in relation to racing I may be charged with such a breach of the Rule. **RULE 340.**
- 5. That I cannot: without reasonable cause break a riding engagement; or permit myself to be engaged to ride two or more horses for the same race; or ride a horse at a weight other than that at which it is handicapped to carry; or be represented by more than one Rider's Agent. **RULE 330 (3).**
- 6. That the ownership of horses by a rider is restricted to that as set out in the Rules. **RULE 333.**
- 7. That NZTR has an 'alcohol free' and 'drug free' policies with regards to riders when riding and if requested by a Racecourse Inspector or Stipendiary Steward, I am required to supply a sample of either my urine, blood, saliva or sweat pursuant to the provisions of the Rules and Protocols and that I am not permitted to leave the racecourse until I have provided the sample or been cleared to leave by an official and all provisions of the relevant Rule applies to me.
  RULE 656.
- 8. That I am only permitted to bet on a horse race or sports event as set out in Rule 707. **RULE 707.**
- That I am not permitted to wear spurs in any flat race or flat trial.
   RULE 611
- 10. That I am not permitted to strike the horse I am riding in a race in a manner or to an extent that is unnecessary, excessive or improper or to carry more than one whip or an unapproved whip, or to strike a horse with a whip foward of its shouler.

  RULE 638 (3) (B).
- 11. That I am responsible for ensuring that all of my riding gear is sound and suitable for use and that I am also required to report to the Stipendiary Stewards immediately after a race, any broken gear in relation to the horse I have ridden.

  RULES 612 and 615.
- 12. That I am not permitted to ride in a race, trial or track work if I have been declared officially unfit to ride, until I have produced to a Stipendiary Steward or Investigator a medical certificate from a registered medical practitioner declaring that I am fit to ride.

  RULES 621.
- 13. That I am aware that there are Rules declaring persons with certain criminal convictions or other Rule disabilities, to be prohibited from being involved in the Racing Industry pursuant to Section 34 of the Racing Act 2003 and the Rules of Racing and that I should approach a Racecourse Inspector if I have any concerns in that regard.
  Third Schedule.
- 14. That I have made myself familiar with the provision of the Rules relating to allowances. RULE 542.
- 15. That I am required to wear at all times when riding, an approved skull cap and approved body protector.

#### **RULES 610.**

- 16. That when weighing out for a race, I am not permitted to carry more than 0.5 kgs over the carded weight without the authority of the Stipendiary Steward.

  RULE 620 (2).
- 17. That I am aware that all riders in every race are required to weigh in at the conclusion of the race. RULE 647 (1).
- 18. That I am aware that upon weighing in, if I cannot draw the approved weight, then I shall be allowed 0.5kgs and if that allowance is not sufficient still to draw the approved weight, then the horse ridden by me is liable to be disqualified and I can be charged with a breach of the Rules.

  RULES 648 (3).
- 19. That I am to weigh in as required by the Rules. That I am not permitted to do or permit any wrongful act or omission with respect to weight or weighing. That I am not permitted to touch any person or anything other than an article of my own equipment before weighing in. RULE 649(1).
- 20. That once at the start, I am under the starters orders and I shall not leave the starting post or dismount from my horse without the permission of the starter.

  RULE 631 (1).
- 21. That as the rider of a horse in a race, I am obliged to take all reasonable and permissible measures throughout the race to ensure my horse is given full opportunity to win the race or obtain the best possible finishing place and position.

  RULE 636 (1) (b).
- 22. That I am obliged to ride my horse out to the end of the race if there is a reasonable chance of it running into a position for which there is prize money to be awarded or a dividend declared.

  RULE 636 (1) (c).
- 23. That as the rider of a horse in a race I cannot trust to the chance of a protest, objection, information or proceeding.
  RULE 636 (1) (d).
- 24. That a horse I am riding shall be disqualified if it runs on the wrong side of parts of the track as set out in the Rule.
  RULE 637(1)(a).
- 25. That when riding a horse in a race, my horse cannot cross another horse without it being at least its own length and one other clear length in front of such horse at the time of crossing.

  RULE 642 (2)(b)(i).
- 26. That I am not permitted to ride a horse in a race in a manner that is foul, reckless, improper, careless or incompetent.
  RULE 638 (1).
- That when riding a horse in a race, I am not permitted to make any celebratory gesture prior to my horse passing the winning post.
   RULE 638(2).
- 28. That as a rider with an engagement at a race meeting, I am required to be present on course at least 40 minutes before the advertised starting time of the first race I am engaged for and unless otherwise permitted by the Stipendiary Stewards, thereafter remain in the jockeys' room and other areas specified by the Stipendiary Stewards, until I have completed my riding engagements, when I must seek the permission of the Stipendiary Stewards to leave.

  RULES 605 (1) and 606.
- 29. That I have made myself familiar with the provisions of the Rules relating to the running of Hurdle and Steeplechase events.

  RULE 639 & 640.
- 30. That I have made myself familiar with my obligations to the trainer of a horse I have ridden in a race as to the procedure involving in lodging a protest. **RULE 642.**

31. That I have made myself familiar with the provisions of the Rules relating to Serious Racing Offences, Breaches of the Rules, and General Penalties.

RULES 801, 802 and 803.
